



# WAYS OF GIVING

There are many ways to make a gift that will benefit the students at Rochester Catholic Schools.

## CASH GIFTS

A cash gift is the simplest way to give, it provides RCS with immediate available funds. To make a cash gift you can pay by credit card online, mail a check or set-up an EFT option (electronic funds transfer).

## PLEDGES

A pledge allows an individual to commit to making a series of donations, even over a period of several years by combining yearly gifts into a multi-year pledge.

## MATCHING GIFTS

Each year, corporations match gifts to RCS through employee matching gift programs. Gifts can be matched by the employer of the donor or their spouse.

## BEQUEST IN YOUR WILL

An individual may designate a bequest of a certain amount or specific item(s) to RCS in their estate plan (whether by Will or Trust).

## ESTATE GIFTS

An individual may also give a lifetime gift by transferring title to real estate you own. This option may allow for significant tax benefits.

## STOCK GIFTS

Like with real estate, there is the option to give a lifetime gift of stocks, bonds or other investment securities (including mutual funds). And like with a gift of real estate this option may yield tremendous tax benefits for you and RCS.

## LIFE INSURANCE GIFTS

An individual can designate RCS as a beneficiary under any new or existing life insurance policy. Depending on how the policy is structured, you may be eligible for tax savings.

## PAYROLL DEDUCTION (RCS STAFF)

If you are employed by RCS, giving a re-occurring monthly gift through payroll deduction is an opportunity that is offered.

### CAPITAL CAMPAIGN

Construction began in the fall of 2011 on the new Lourdes High School, located at the corner of 19th Street and Valleyhigh Drive NW in Rochester. An exceptionally mild winter and favorable spring and summer allowed for tremendous construction progress.

It is anticipated the building will be complete in April 2013, which will accommodate a Fall 2013 opening of the new school. Dedication for the new building has been scheduled for September 15, 2013.


